

## INFORMATION ON THE PROCESSING OF PERSONAL DATA

**CAMPING GARDEN PARADISO S.P.A.**, with registered office in Via F. Baracca, 55, 30013 Cavallino-Treporti VE in its capacity as holder of the personal data processing (hereinafter referred to as 'Holder'), issues this information notice to the Customer (hereinafter also referred to as 'Interested Party') in compliance with the European and Italian regulations on personal data protection.

The Data Controller has appointed a Data Protection Officer (DPO), whom the Data Subject may contact by writing to the following address: [dpo@gardenparadiso.it](mailto:dpo@gardenparadiso.it)

### Purpose and legal basis of processing

The Controller processes personal data for several purposes:

- 1) to allow the User to access the Internet in wi-fi mode and to access the relative services, as well as to allow the Controller to carry out all related administrative, accounting and fiscal activities and to fulfil, more generally, all the legal obligations to which it is bound: the legal basis of the processing is the need for the pursuit of the above-mentioned purposes;
- 2) use the data subject's contact details (e-mail address) to carry out opinion and approval surveys, send commercial communications containing information on products or services, as well as promotions or invitations to events in which the Data Controller will participate: express consent is required for this purpose, which may be given and revoked even for some of the above activities;

### Data retention period

The Data Controller intends to process the data according to the following time criteria:

- 1) 6 months from the last access to the wifi network, without prejudice to further storage for the time required to settle (however reached) any disputes that may have arisen;
- 2) the data provided to enable the Controller to carry out the commercial communications described above shall be processed for 24 months from the last communication, regardless of the channel used;

### Nature of data provision and consequences in the event of refusal

The provision of data for the purposes set out in point 1) is necessary and therefore any refusal to provide such data in whole or in part may make it impossible for the Controller to pursue the above-mentioned purposes. The provision of data for further purposes is optional: in the absence thereof, the Data Controller will not be able to carry out the corresponding activities but will still be entitled to pursue the purposes set out in point 1).

### Categories of recipients

The Data Controller will not disseminate the data, but intends to disclose them to internal figures authorised to process them by reason of their respective duties, as well as to Group companies, and to professionals or service companies, as well as to public and private bodies, also following inspections and audits.

These recipients, should they process data on behalf of the Data Controller, will be appointed as data processors with a specific contract or other legal act.

### Transfer of data to a third country and/or international organisation

Personal data will not be transferred either to non-European third countries or to international organisations.

### Rights of data subjects

The data subject has the right to ask the Controller to access his/her personal data and to rectify them if they are inaccurate, to cancel or limit their processing if the conditions are met, to object to their processing for legitimate interests pursued by the Controller, as well as to obtain the portability of the data personally provided only if they are subject to automated processing based on consent or contract. The data subject also has the right to revoke the consent given for the purposes of processing that require it, without prejudice to the lawfulness of the processing carried out up to the time of revocation.
